**AN ORDINANCE AUTHORIZING THE MAYOR OR ADMINISTRATOR TO ENTER INTO CONTRACTS WITH THE COLUMBUS CITY ATTORNEY FOR THE PROSECUTION OF CASES BEFORE THE FRANKLIN COUNTY MUNICIPAL COURT, THE FRANKLIN COUNTY PUBLIC DEFENDER COMMISSION TO PROVIDE INDIGENT DEFENSE REPRESENTATION, AND THE FRANKLIN COUNTY BOARD OF HEALTH FOR PLUMBING INSPECTIONS AND TO DECLARE AN EMERGENCY**

**WHEREAS**, the Village of Obetz annually enters into contracts with the Columbus City Attorney's Office to provide for the prosecution of cases before the Franklin County Municipal Court, the Franklin County Public Defender Commission to provide indigent defense representation and the Franklin County Board of Health for plumbing inspections; and

**WHEREAS**, the Village desires to enter contracts with these same agencies for continuing services,

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ THAT;**


Section 1. The Mayor or Administrator is hereby authorized to enter into contracts with the Columbus City Attorney's Office to provide for the prosecution of cases before the Franklin County Municipal Court, the Franklin County Public Defender Commission to provide indigent defense representation, and the Franklin County Board of Health for plumbing inspections in a form substantially similar to the agreements attached hereto Exhibits A, B, and C respectively and incorporated herein by reference.



Wherefore, this ordinance shall be in force and take effect immediately upon its passage.
