Ordinance No. 05-10

Passed February 22, 2010

**AN ORDINANCE TO AMEND THE 2010 TEMPORARY APPROPRIATIONS REGARDING THE STREET MAINTENANCE FUND AND TO DECLARE AN EMERGENCY.**

**WHEREAS**, a need exists to amend the 2010 temporary appropriations to add funds for repairs and maintenance relating to the Street Maintenance Fund; and

**WHEREAS**, Ordinance Number 35-09 approved the 2010 temporary appropriations for the current expenses and other expenditures of the Village; and

**WHEREAS**, these temporary appropriations are to be effective from January 1, 2010 to March 31, 2010;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:**

Section 1. The 2010 temporary appropriations are hereby amended by changing the appropriations as set forth below:

	<u>Original</u>	<u>Revised</u>
Fund No. 2011-630-433	\$2,000.00	\$7,500.00

Section 2. The Fiscal Officer shall certify these additional appropriations with the Franklin County Budget Commission.

Section 3. This Ordinance shall be declared an emergency and shall take effect at the earliest time permitted by law. The reason for the emergency is to provide for the public health, safety, and welfare of the citizens of the Village of Obetz. Specifically, the Village needs to increase the temporary appropriations budget for the repairs and maintenance of the Street Department vehicles in order for the Village to continue safe operations.
