**A RESOLUTION REQUESTING THE OHIO DEPARTMENT OF TRANSPORTATION TO REDUCE THE SPEED LIMIT ON ALUM CREEK DRIVE, COUNTY ROAD NO. 22, FRANKLIN COUNTY, AND TO DECLARE AN EMERGENCY.**

**WHEREAS**, the Franklin County Engineer's Office has completed a speed study on Alum Creek Drive, the results of which require the Village of Obetz to request the Ohio Department of Transportation to evaluate the present speed limit; and,

**WHEREAS**, the section of Alum Creek Drive which was studied is from Rathmell Road to Howard Road, a total distance of 1.00 miles, and such section is shown on the map attached hereto as Exhibit A and incorporated herein by reference; and,

**WHEREAS**, the speed limit on this section of Alum Creek Drive is currently posted as 50 miles per hour, and the County Engineer's study warrants a speed limit of 45 miles per hour;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:**

Section 1. The Ohio Department of Transportation (ODOT) is hereby requested to evaluate the County Engineer's speed study and determine the safe speed limit on the section of Alum Creek Drive, County Road No. 122, Franklin County, shown on the map attached hereto as Exhibit A.

Section 2. In the event that ODOT determines that 45 miles per hour is warranted, appropriate signs shall be erected.

Section 3. This resolution shall be declared an emergency and shall take effect from and after its passage. The reason for the emergency is to provide for the public health, safety and welfare of the citizens of the Village of Obetz. Specifically, the Village needs change the speed limit on Alum Creek Drive to ensure the safety of motorists.

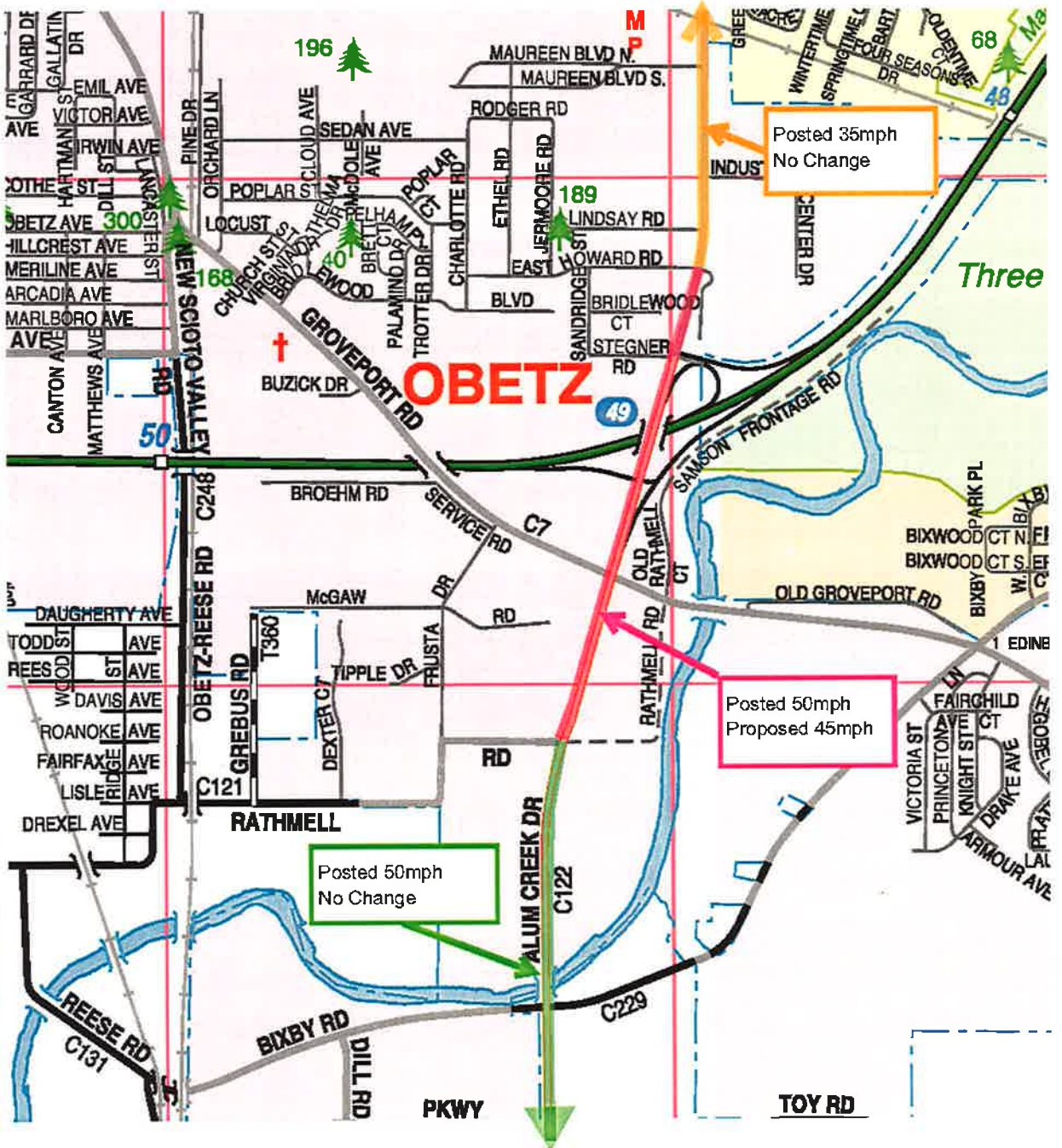


